HOUSE RULES *For Guests*

Welcome to Coral Casino Bonaire.

We are committed to providing a safe, enjoyable, and responsible gaming environment for all our guests. To ensure everyone has a positive experience, we kindly ask that all visitors adhere to the following house rules:



GENERAL CONDUCT

Respectful Behavior: Guests must behave respectfully toward fellow patrons, casino staff, and property at all times. Aggressive, disruptive, or abusive behavior will not be tolerated.

Dress Code: Smart casual attire is required.
(No overly revealing clothing allowed.)

Alcohol & Substance Use: Guests who appear intoxicated or under the influence of substances may be denied entry or asked to leave. No outside alcohol or drugs are allowed on the premises.

Follow Instructions: Guests must follow all instructions given by authorized casino staff, when such instructions are intended to ensure safety, order, or fair play within the casino.





ACCESS & IDENTIFICATION

Minimum Age: Entry is restricted to guests aged 21 and older.

Identification: A valid government-issued photo ID (passport, driver's license, or ID card) is required for entry, all transactions and must be presented upon request at any time during your visit.

Definition of Casino Area:

The term "casino" includes all areas open to guests, including but not limited to the gaming floor, bar, and any other public areas within the premises.



GAMING & PAYMENTS

Responsible Gaming: We promote responsible gaming. If you feel you may have a problem, please speak to a staff member or ask about our self-exclusion options.

No Credit Extension: The casino does not offer credit.



SECURITY & SURVEILLANCE

Surveillance: For your safety, the casino is under 24/7 video surveillance. All activity is monitored.

Bag Checks: Security may request to inspect bags at entry or exit.

Lost & Found: Found items are turned in to Security. Inquire at the reception desk for assistance.



PROHIBITED ACTIONS

No Photography or Filming: Taking photos or videos in the gaming area is strictly prohibited.

Prohibited Equipment: The use of spy devices, electronic aids, or recording devices is forbidden in or near gaming areas, except for mobile phones in designated areas.

Use of Devices at Tables: Use of phones, tablets, or other electronic devices is not permitted while seated at a gaming table, unless allowed for specific games as approved by management.

Cheating or Collusion: Any attempt to manipulate games or collude with others will result in immediate removal and possible legal action.

No Animals: Only certified service animals are permitted on premises.



TABLE SEATING

Seats at gaming tables are reserved for guests **actively participating** in the game.



SLOT MACHINE RESERVATION

A slot machine may be reserved for a **maximum of 15 minutes**. If the guest does not return within this time, the machine will be made available to other players.

For all slot machines issues or disputes, please contact the slot department.





MANAGEMENT RIGHTS TO REFUSE ENTRY

Management reserves the right to refuse entry or service to anyone who:

- Does not meet the entry requirements
- Appears to be disorderly or likely to disrupt games or other guests
- Breaches these house rules
- Is self-excluded or otherwise restricted from entry
- Exhibits gaming behavior that may be harmful to themselves or others.

In compliance with applicable laws, including anti-money laundering regulations, the casino reserves the right to refuse entry or discontinue a guest relationship if required by law or if the casino has reason to believe that continuing the relationship could cause reputational, legal, political, or operational harm. Upon request, the casino will inform the guest of the reason for such a decision.



RESPONSIBLE GAMING ENFORCEMENT

Management may deny entry or impose restrictions if gaming behavior is considered harmful to the guest or their dependents.



COMPLIANCE CHECKS

Guests must cooperate with all security, compliance, and rule enforcement checks. Refusal may result in removal from the premises.



OPERATING HOURS

Opening Hours: Mon – Sat 08:00 PM – 04:00 AM /
Sun 07:00 PM – 03:00 AM

Guests must vacate the premises promptly at closing time unless otherwise permitted by management.



CHANGES

These rules are subject to change at management's discretion. Updated rules will be posted as needed.
